**JOB SUMMARY**: Performs skilled work related to the installation, maintenance and repair of all electrical equipment and components, including roadway street lighting, traffic signals, municipal buildings and facilities.

**SUPERVISION EXERCISED**: May supervise General Maintenance Workers when assigned to assist with projects.

#### ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Maintains the electrical systems of new roadway street lights, traffic lights, and municipal buildings and facilities.
- Performs all preventive maintenance of Electrical Division vehicles and equipment.
- Provides technical assistance to the Electrical Superintendent.
- Maintains all inventory within the division.
- Performs electrical related tasks without direct supervision.
- Prepares reports and analyses of electrical activities.
- Maintains a safe working environment.
- Installs and maintains telephone and computer wiring.
- Attends training courses regarding current practices in the electrical field.

#### **OTHER DUTIES:**

- Responds to complaints and inquiries from the public regarding electrical problems.
- Responds to emergency calls when necessary.
- Performs other related duties as required.

# **DESIRED MINIMUM QUALIFICATIONS:**

## **Education and Experience:**

- High school diploma;
- Prefer five (5) years progressively responsible experience as a Certified Journeyman Electrician, including commercial and service related electrical work, and
- Any related combination of training and experience.

### Knowledge, Skills and Abilities:

• Thorough knowledge of practices, procedures, methods and tools relative to electrical trades and operations.

- Thorough knowledge and skill in the care and use of power tools, including safety precautions and occupational hazards related to electrical maintenance and repair work.
- Considerable knowledge of the operation and maintenance of electrical equipment, motors and motor controls.
- Ability to prepare labor and material cost estimates to complete various projects.
- Ability to read blueprints, specifications, plans.
- Ability to read and interpret tests, gauges and meters.
- Ability to prepare operational reports.
- Ability to establish and maintain effective working relationships with other employees and the general public.
- Ability to communicate effectively both orally and in writing.
- Completion of NIMS Training as required

### **SPECIAL REQUIREMENTS:**

- Valid Florida State driver's license, or ability to obtain one; No more than 2 moving violations in the last 12 months, no more than 6 violation points in the last 24 months.
- Palm Beach County Journeyman Electrical Certificate
- Operation of a bucket truck.
- CPR

#### **PHYSICAL DEMANDS:**

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is frequently required to stand, walk, sit, talk, hear, and use hands to manipulate, handle, feel or operate objects, tools, or controls, and reach with hands and arms. The employee is frequently required to climb up 30-foot ladders, walk up and down staircases, balance, stoop, kneel, crouch, or crawl.

The employee must regularly lift and/or move up to 50 pounds. Specific vision abilities required by this job include close vision, distant vision, color vision, peripheral vision, depth perception, and ability to adjust focus.

### **TOOLS & EQUIPMENT USED:**

Electrician hand tools, power tools, shovels, bucket truck, test equipment, pipe benders, ladders, trenching, and other associated equipment used in the installation, operation, maintenance and repair of electrical equipment and facilities.

#### **ENVIRONMENTAL CONDITIONS:**

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable

accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee frequently works in outside weather conditions, and is exposed to wet and/or humid conditions, toxic or caustic chemicals. The noise level in the work environment is moderately noisy or loud when in the field.
