#### Issue:

The applicants, Sylvio Pierre-Louis and Ashley Turnquest, on behalf of the Village of Royal Palm Beach, are requesting a Special Events Permit to conduct the Village's annual Fall festival event titled "Rock N Fall Fest". The event will take place at the Royal Palm Beach Commons Park from Friday, October 4, 2024 from 5:00 p.m. to 10:00 p.m. and Saturday, October 5, 2024 from 1:00 p.m. to 9:00 p.m.

- 1. The event may take place on Friday, October 4, 2024 from 5:00 p.m. until 10:00 p.m.; and Saturday, October 5, 2024 from 1:00 p.m. until 9:00 p.m. at Royal Palm Beach Commons.

- 3. All electrical circuits shall be GFI protected.
- 4. A clearly defined parking area must be provided.
- 5. The applicant shall provide for portable restroom facilities including at least one handicapped accessible facility if public facilities are not within 500' of accessibility.
- 6. Adequate trash receptacles shall be provided for debris, which may accumulate on site.
