# Agenda Item:

Approval of bid award and authorization for the Village Manager to enter into contract with Epicurean Park, LLC, dba Nex Era Services, the lowest responsive, responsible bidder, in the amount of \$105,000.00 for Grounds Maintenance Service on Crestwood Boulevard and the Village Hall complex.

### Issue:

Grounds Maintenance Service on Crestwood Boulevard and the Village Hall complex was added to our existing Roadway Grounds Maintenance on a monthly basis in June 2024. Public Works has budgeted this work in our FY2025 budget.

Proposals were solicited for Grounds Maintenance Service Crestwood Boulevard & Village Hall Complex on August 5, 2024. A total of five (5) bids were received timely and in accordance with the sealed bid requirements.<sup>1</sup> Epicurean Park, LLC, dba NexEra Services is the lowest responsive, responsible bidder for Crestwood Boulevard and the Village Hall complex grounds maintenance work as shown on the attached bid tabulation.

This contract is for a one (1) year term and may be extended for two (2) additional one (1) year terms provided both parties agree.
