Agenda Item Summary

AGENDA ITEM: Move and appoint the current Alternate #2 member to the Alternate #1 seat and appointment of one new alternate member to the Planning & Zoning Commission for a term expiring March 2025.

ISSUE: Alternate #1 member Jonathan Dickinson resigned from the Planning & Zoning Commission, leaving a vacancy in the Alternate #1 seat on the Planning & Zoning Commission.
