IV. ITEMS FOR DISCUSSION

- 1. Ordinance No. 1051 proposes to amend the Village Code of Ordinances at Chapter 26. Zoning., Article V. Zoning Districts. at Sections 26-82 – RV-6 Villa Residential District and 26-83. RT-8 Townhouse Residential District. to eliminate the perimeter landscape setback requirement adjacent to right-of-ways and open space and the requirement for a 10-foot perimeter landscape setback adjacent to interior property lines for parcels with yards of ten feet or greater.
- 2. Ordinance No. 1054 proposes to amend the Village Code of Ordinances at Sec. 11.5-2 to update the Flood Insurance Study date, at Sec. 11.5-20 to correct a scrivener's error (extra spacing) to combine paragraphs in the definition for the term "start of construction", at Sec. 11.5-30 to allow accessory structures in flood hazard areas under certain circumstances, and Sec. 11.5-37 to remove local amendments regarding elevation requirements which have become part of Sec. 11.5-30 of the Village Code.
