Canal Bank Stabilization Response to RFI # 2

To All Bidders:

- 1. Why does the addendum 1 Plans and the Bid Documents have different project titles?
 - a. The Bid Documents & Plans are both labeled "Canal Bank Stabilization Project PW1806". The Addendum Number One was inadvertently labeled "Bridge Slope Stabilization – PW1806". We have attached a revised Addendum Number One cover sheet labeled "Canal Bank Stabilization".
- 2. Why does addendum 1 plan cover only show 1 area of construction? should the addendum show both areas?
 - a. As discussed at the pre-bid meeting on February 26, 2020, there are two site locations. Both sites are on Royal Palm Beach Boulevard, north of Okeechobee Boulevard. Each site location has two (2) bridges. Addendum Number One was issued to:
 - Revise the Bid Form and Bid Proposal Form to establish a Base Bid & Alternate Bid.
 - 1. The northernmost site is the Base Bid and includes bridges; 937363 (E) and 937361 (W).
 - 2. The southernmost site is the Alternate Bid and includes bridges; 937362 (SE) and 937352 (SW).
 - b. Each site location has a set of plans, which can be distinguished by the bridge numbers for each site location.
 - c. Addendum Number One included a revision to the southernmost site to show the correct Site Map and Location Map.
- 3. Can the Village revise these documents to be accurate? name and show both locations to be bid on?
 - a. No revisions are needed to the bid documents.
 - b. Each site location has a set of plans, which can be distinguished by the bridge numbers for each site location.
 - c. Addendum Number One included a revision to the southernmost site to show the correct Site Map and Location Map.

- 4. Can you give an aerial map showing both bridges for construction?
 - a. The Site Map and Location Map on the plans for each site show the location for the work.
 - b. Each site location has a set of plans, which can be distinguished by the bridge numbers for each site location.
 - c. Addendum Number One included a revision to the southernmost site to show the correct Site Map and Location Map.
- 5. Is there a material estimate for rip rap, bedding, fabric, dredge material etc... for each location?
 - a. Please refer to RFI #1 for the response to this question.
- 6. Is the project budget of \$420,000 include both bridges or only the one in the original bid plans?
 - a. As discussed in the pre-bid meeting, the project budget is \$420,000. As stated above, Addendum Number One was issued to:
 - Revise the Bid Form and Bid Proposal Form to establish a Base Bid & Alternate Bid.
 - 1. The northernmost site is the Base Bid and includes bridges; 937363 (E) and 937361 (W).
 - a. As shown in Addendum Number One, the Engineer's opinion of probable cost for this site is \$295,000.
 - 2. The southernmost site is the Alternate Bid and includes bridges; 937362 (SE) and 937352 (SW).
 - a. As shown in Addendum Number One, the Engineer's opinion of probable cost for this site is \$275,000.
