Final Budget Hearing was called to order on September 19, 2019 at 6:30 p.m.

The following action was taken:

- Announced proposed operating millage rate to fund budget is 4.13% above the rolled-back rate of 1.8438 mils.
- Announced proposed millage rate is 1.9200 for the General Fund.
- Adopted Res. 19-23 and the final millage rate of 1.9200 for FY 2019/2020 .
- Adopted Res. 19-24 and the final budget for FY 2019/2020.

Council Regular Meeting was called to order immediately after the Final Public Budget Hearing Thursday, September 19, 2019

The following action was taken:

- Renewed annual software licensing and software maintenance support with Superior Public Sector, Inc. for \$60,000.
- Approved budget amendment for Fund 303 in FY 2018/2019 to transfer \$65,000 from Undesignated Fund Balance to Veterans Park Walkway.
- Approved grant to American Legion Post No. 367 in the amount of \$480 for space rental costs.
- Approved agreement with Broadcast Systems, Inc. in the amount of \$100,000 for security cameras at the Recreation Ctr, Katz Soccer Complex and Camellia Park.
- Approved first Addendum to Communication Plan Professional Services Agreement with MY PR Guru.

- Approved Fourth Addendum to the Law Enforcement Service Agreement with PBSO.
- Adopted Res. 19-26 a revised Schedule of Fees and Charges.
- Awarded bid in the amount of \$931,990.16 for Road Resurfacing to Rapid Milling and Paving LLC.
- Approved addendum to extend Bridge Construction and Inspection Services with Alan Gerwig & Associates for two years.
- Approved Professional Services Agreement for Landscape Architect Services with Cotleur & Hearing.
- Approved Professional Services Agreement for Stormwater Engineering Services with CDM Smith, Inc.
- Approved a supplemental grant agreement with FDOT for the construction of ADA improvements in the neighborhoods of the Colony and Counterpoint Estates.
- Approved Special Event Permit for PBSO to hold a Night Out Against Crime at Target on Friday, Oct. 4th.
- Approved Special Event Permit for RPB to hold a Green Market and Bazaar at Village Hall every Saturday October 19th—April 25th from 9:00 am—1:00 pm.
- Approved Special Event Permit for the American Cancer Society to hold a "Glow in the Dark Fun Run 5K" - Saturday, January 18th from 5:30 pm to 8:30 pm.
- Bid awarded to Epicurean Park, LLC for Roadway Grounds Maintenance Service on State Road 7 and State Road 80 in the amount of \$242,399.41.



- Bid awarded to U.S. Sweeping, Inc. for Street Sweeping in the amount of \$26,348.41.
- Adopted Ord. 994 granting 30-year electric franchise to FP & L.
- Adopted Ord. No. 992 a change of land use designation for a parcel of land totaling 13.144 acres located on the south side of Southern Boulevard approximately 0.27 miles west of State Road 7.
- Approved First Reading of Ord. 995 amending Chapter 15. Landscaping and Vegetation Management.
- Appointed Councilwoman Jan Rodusky as a regular member and Councilman Richard Valuntas as an alternate member to the Issues Forum of IPARC.
